Variations to the Notifications under Tamil Nadu General Sales Tax Act.

No.II (1) / CTR / 35 / 2006. – In exercise of the powers conferred by sub-section (3) of Section 17 of the Tamil Nadu General Sales Tax Act, 1959 (Tamil Nadu Act 1 of 1959), the Governor of Tamil Nadu hereby makes the following variation to the Commercial Taxes and Religious Endowments Department Notification No.II(1)/CTRE/70/97, dated the 15th September 1997, published at page 64 of Part II – Section 1 of the *Tamil Nadu Government Gazette*, dated the 1st October 1997, as subsequently amended.

In the said Notification, for the expression "Thiruvallur Ford India Limited" wherever it occurs, the expression "Thiruvallur Ford India Private Limited" shall be substituted.

Exemption from the Payment of Sales Tax and Surcharge on the purchase of Animal Ambulance Vehicle for Thiruvallur Blue Cross of India.

G.O. (Ms.) No.69, Commercial Taxes and Registration (B2), 19th July 2006.]

No.II (1) / CTR / 38 / 2006. – In exercise of the powers conferred by subsection (1) of Section 17 of the Tamil Nadu General Sales Tax Act, 1959 (Tamil Nadu Act 1 of 1959), the Governor of Tamil Nadu hereby makes an exemption in respect of the sales tax and surcharge amounting to Rs.66,780 (Rupees Sixty six thousand seven hundred and eighty only) payable under the said Act on the sale of an Animal Ambulance Vehicle bearing Registration No.TN 07 AE 4667 to Thiruvallur Blue Cross of India, Chennai.

2. The Notification shall be deemed to have come into force with effect on and from the 28th March 2005.
